## POLICIES and PROCEDURES

### LICENSE OF OCCUPANCY

1. **NEW THIS YEAR** If you require any park equipment usage a **"Request For Service Waiver"** must be filled out and sent electronically.
2. Silver Lake's season begins **May 15th** and ends **Thanksgiving** weekend.
3. Seasonal payment is **Due May 1st**, before the season starts. Any payment *after May 1st* is considered late and extra charges will apply.
4. Winter deposit is due **Labour Day** weekend.
5. All deposits are non-refundable.
6. Camper's visitors will be charged regular day rates. Seasonal campers can purchase a seasonal visitor's pass for "their" own visitor while you are there. Any guest staying the night must be in your trailer.
7. A 2nd family using your trailer while you are not there is required to purchase their own signed seasonal contract for 20% of the seasonal rate.
8. A family rate is considered to be 1 Parental Couple, and any children living at home under the age of 18.
9. Pets are allowed but must be on a non-retractable leash no longer than 6 feet. Cross and or barking dogs will not be tolerated.
10. ATV's are for work purposes only. They can get you from point A to point B. Golf carts must be used respectfully in the camp. All drivers must have a valid driver's license and insurance and no cart usage is permitted by campers after 11PM. Mini/dirt bikes are not allowed.
11. No clotheslines tied to trees please.
12. Speed limit is 10 km/hr on camp property.
13. Respect other camper's lots. Do not trespass on private lots or docks.
14. All buildings on campsites must be approved by management. Sheds must be placed in line with trailer. Sheds are for storage and not sleeping quarters and must be manufactured by H & H Patio only. NO stick built structures allowed.
15. Refrigerators must be concealed from sight in a shed.
16. No For Sale signs permitted on trailer or campsite.
17. All trailer sales must be approved through the office. Impact/pad fees will apply to both new and used trailers. Do not assume you can sell your trailer on site. Your contract is not transferable if trailer is sold.
18. Alcohol must be kept on campsites. This is a Provincial Law. Underage drinking will not be tolerated. Cannabis is to be on your campsite only. Be mindful of neighbours or the rules will change where we see fit. No smoking or vaping at boathouse, docks, park or beach.
19. Children under the age of 18 must be on campsite by 11:00 pm.
20. All noise must cease by midnight. Unruly conduct can cause your contract to be cancelled without refund.
21. Campsites must be left neat and tidy; this includes cutting grass. Cost of the camp cutting grass if seen needed will be billed \$50 each time.
22. No digging on the campsite unless authorized by management
23. Trees, shrubs and plants must not be cut, damaged or removed without approval.
24. **NO WEAPONS OF ANY KIND ARE ALLOWED.**
25. Theft or vandalism will be persecuted to the maximum the law will permit.
26. No personal watercraft are allowed on camp property.
27. **TRAILER OWNERS WILL BE RESPONSIBLE FOR ANY FUTURE TAXES OR FEES THAT MIGHT BE BROUGHT INTO EFFECT BY THE TOWNSHIP OR GOVERNMENT.**
28. Occupancy is governed by the Trespass and Property Act of Ontario RSO 1980 C. 511. One warning will be given.
29. The signed license of occupancy, Liability Waiver and Policies and Procedures are all part of your seasonal contract, please keep a copy for your records.
30. A detailed description of all Silver Lake's Policies and Procedures can be found on their website [www.silverlaketentandtrailerpark.ca](http://www.silverlaketentandtrailerpark.ca) or you can request a printed copy from the office for pick up.
31. Any recreational vehicle left at Silver Lake Tent & Trailer Park is at owner's own risk. We urge you to have an Insurance Policy for the whole year for your own protection.
32. Rules are subject to change without notice.
